Dear Commissioner Stoll:

I am pleased to summarize efforts we have undertaken to increase awareness of and stimulate participation in MGE's *Rebuild Joplin* energy-efficiency rebate program which became effective on December 9, 2011 due to action by the Missouri Public Service Commission.
