### MOTION FOR EXPEDITED TREATMENT OF TARIFF FILINGS

AT&T Missouri¹ respectfully requests the Missouri Public Service Commission ("Commission") to expedite its approval of tariff revisions being made to reflect AT&T Missouri's restructuring as a Missouri corporation.

- 1. On June 18, 2007, AT&T Missouri filed its Notice of Reversion to Missouri Corporate Form, Alternative Application for Authorization and Request for Waivers seeking approval from the Commission to revert from a Texas limited partnership to a Missouri corporation. AT&T Missouri also filed a Motion for Expedited Treatment seeking a Commission determination no later than June 26, 2007 (with a June 29, 2007, effective date).
- 2. On June 26, 2007, the Commission voted to grant AT&T Missouri's Application concerning its proposed reorganization as a Missouri corporation. In order to effectuate the Commission's determination, AT&T Missouri has filed proposed tariff adoption notices and revised tariff title sheets to recognize AT&T Missouri's corporate reorganization (i.e., from Southwestern Bell Telephone, L.P., a Texas limited partnership to Southwestern Bell Telephone Company, a Missouri corporation). In accordance with Commission rule 4 CSR 240-3.545(18),

AT&T Missouri submitted the proposed tariff with a June 26, 2007, issued and a July 26, 2007, effective dates.

- 3. AT&T Missouri seeks expedited approval of the proposed tariff adoption notice and revised title sheets (with a June 29, 2007, effective date), in order to ensure that it has tariffs reflecting its provision of services as Southwestern Bell Telephone Company in effect on the date its corporate reorganization is completed. A copy of the filing letters from Alan Kern to the Secretary of the Commission, dated June 26, 2007, enclosing the revised tariff sheets is appended to this Motion as Attachment 1.
- 4. AT&T Missouri respectfully requests Commission action to approve AT&T Missouri's tariff adoption notices and revised title sheets on an expedited basis with a June 29, 2007, effective date, the date that AT&T Missouri will begin providing telecommunications to Missouri customers as a Missouri corporation. There will be no negative effect on AT&T Missouri's customers or the general public if the Commission acts by this date.
- 5. AT&T Missouri filed this Motion for Expedited Treatment as soon as possible after the Commission voted to approve the corporate reorganization.
- 6. AT&T Missouri notes that it anticipates filing evidence of the registration of Southwestern Bell Telephone Company's fictitious name ("AT&T Missouri") with the Missouri Secretary of State as soon as it is available.

WHEREFORE, AT&T Missouri respectfully requests the Commission grant this Motion for Expedited Treatment and approve AT&T Missouri's tariff adoption notices and revised tariff title pages with an effective date of June 29, 2007, thereby ensuring that Southwestern Bell

Telephone Company has tariffs in effect on the date it begins to provide telecommunications services to Missouri customers.
