**NOTIFICATION OF RESOLUTION OF CERTAIN ISSUES AND REQUEST  
FOR EXPEDITED TREATMENT FOR TARIFF**

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company), and on behalf of itself, the Office of Public Counsel (OPC), the Staff of the Missouri Public Service Commission (Staff) and the Missouri Department of Natural Resources (DNR), states as follows:

1. Concurrent with this filing, Ameren Missouri is filing a tariff (copy attached) to modify its natural gas Equipment and Building Shell Measure Rebate Program, to reflect the fact that the Company has committed to additional funding, as necessary, in order to keep the program available to its customers. The tariff also reduces the amount of energy efficiency program funds that Ameren Missouri may spend on advertising for the 2010 program.

2. These changes have been reviewed by and approved by Staff, OPC and DNR. All parties have indicated to Ameren Missouri counsel that she may represent to the Commission their agreement to the language of this tariff.

3. Because this tariff is for the Company's 2010 program, it needs to be approved earlier than would occur with the normal process, which takes 30 days. Ameren Missouri asks the Missouri Public Service Commission (Commission) to approve this tariff so that it is effective by December 16. Ameren Missouri is already

taking customer reservation rebate applications as if this change has been approved by the Commission and this tariff change aligns the language of the tariff with this fact. Approving this tariff early will not result in any negative effect on Ameren Missouri's customers or upon the general public. This pleading was filed as soon as the parties were able to reach agreement upon the language of this tariff.

4. The Company, OPC, Staff and DNR are in agreement that this tariff resolves all outstanding issues related to the 2010 program, including all 2010 issues raised in OPC's previous pleadings. It does not resolve 2011 program issues.

WHEREFORE, Ameren Missouri files this pleading requesting the Missouri Public Service Commission approve the tariff changes and issue that approval so that the change may take effect no later than December 16, 2010.
