## MOTION TO MODIFY DATE BY WHICH UPDATED TARIFF SHEETS MUST BE FILED

**COMES NOW,** Union Electric Company d/b/a AmerenUE (Company) and for its *Motion to Modify Date by Which Updated Tariff Sheets Must be Filed*, states as follows:

- 1. On March 28, 2008, AmerenUE and Pemiscot-Dunklin Electric Cooperative, Inc. (Pemiscot-Dunklin) filed a joint application to transfer approximately 2,700 Dunklin County structures from AmerenUE to Pemiscot-Dunklin.
- 2. On June 11, 2008, AmerenUE, Pemiscot-Dunklin, the Staff (Staff) of the Missouri Public Service Commission (Commission) and the Office of the Public Counsel (OPC) filed a *Unanimous Stipulation and Agreement* in favor of the proposed transaction.
- 3. On June 24, 2008, the Commission issued its *Report and Order Approving Joint Application and Unanimous Stipulation and Agreement Regarding the Joint Application* (Order). The *Order* approved the transfer of structures from AmerenUE to Pemiscot-Dunklin.

- 4. The Order required AmerenUE to file updated tariff sheets reflecting the changes to its certificated service territory no later than July 24, 2008.
- 5. AmerenUE inadvertently missed this requirement in the June 24, 2008 order and so has not yet complied with this portion of the Commission's Order. However, AmerenUE believes there is good reason to request the Commission extend the deadline for filing the required tariff changes.
- 6. As the Commission is aware, the sale to Pemiscot-Dunklin was dependent upon Pemiscot-Dunklin completing the construction of a new transmission line so that it could serve the transferred structures. At this time, the construction is underway but is not yet complete and no structures have yet been transferred from AmerenUE to Pemiscot-Dunklin under the contract. As per the terms of the contract, Pemiscot-Dunklin has until the end of this year (2008) to complete the construction of the transmission line. After the transmission line has been completed, AmerenUE will transfer the structures to Pemiscot-Dunklin.
- 7. Accordingly, these structures are, at this time, still within AmerenUE's service territory and are currently still served by AmerenUE. Once the transmission line is complete and the structures have been transferred, then AmerenUE believes it appropriate to file new tariffs to reflect the change in its service territory. AmerenUE will file updated tariffs 30 days after the date of the transfer of structures.
- 8. In order to assure that the Commission is kept informed on the progress of this transfer, AmerenUE also believes it would be appropriate to make a filing in this case notifying the Commission of the completion of the transfer of structures from AmerenUE

to Pemiscot-Dunklin. AmerenUE will then file updated tariff sheets reflecting the changes to its certificated service territory within 30 days of the transfer of structures.

WHEREFORE, AmerenUE respectfully requests that the Commission order it to file updated tariff sheets reflecting the changes to its certificated service territory no later than 30 days after the transfer of customers from AmerenUE to Pemiscot-Dunklin.
