On May 22, 2017, the Commission issued an order setting a May 30 deadline for the filing of recommendations or objections concerning tariffs sheets (Tracking No. YG-2017-0237) submitted by Summit Natural Gas of Missouri, Inc. ("Summit"). The tariff sheets set June 11, as the effective date. On May 24, Summit submitted a letter to the Commission stating that it was voluntarily extending the effective date of the tariff sheets from June 11 to June 30.

The Commission will extend the May 30 deadline for the filing of recommendations or objections concerning Summit's tariff sheets.

THE COMMISSION ORDERS THAT:

1. The May 30, 2017, deadline for parties to file recommendations or objections to Summit's tariff sheets, assigned Tracking No. YG-2017-0237, is hereby extended to June 19, 2017.
