ORDER DISMISSING APPLICATION

Issue Date: October 4, 2017 Effective Date: October 16, 2017

On July 21, 2017, World Fuel Services, Inc. filed an *Application for Certification as a Seller of Energy Services in the State of Missouri*. On September 11, 2017, Staff filed a recommendation advising the Commission to dismiss the application because World Fuel Services does not need to be certified as a seller of energy services¹.

World Fuel seeks certification under 393.299, RSMo, which requires persons (except distributors or a political subdivision itself) who provide energy services in any county, municipality, or village in Missouri to apply to the Commission for certification as an energy seller.

In their recommendation, Staff states that the only energy services World Fuel intends to provide in Missouri would consist of "upstream" natural gas transactions, where title to the natural gas transfers outside of the Local Gas Distribution Companies' city gate. Staff explains that the statute applies only to energy sellers who transfer title to gas "downstream" of a Local Gas Distribution Companies' city gate. Therefore, Staff concludes World Fuel does not need to be certified as an energy seller under the statute.

No other party has responded to Staff's recommendation and the Commission finds that recommendation persuasive. On the basis of Staff's recommendation, the Commission concludes that World Fuel does not need to be certified as an energy seller. For that reason, the Commission will dismiss World Fuel's application.

THE COMMISSION ORDERS THAT:

- World Fuel Services, Inc.'s Application for Certification as a Seller of Energy
 Services in the State of Missouri is dismissed.
 - 2. This order shall become effective on October 16, 2017.
 - 3. This file shall be closed on October 17, 2017.
