**ORDER GRANTING MOTION FOR EXTENSION OF TIME**

On August 5, 2022, Spire Missouri Inc. (Spire) filed an application which seeks permission and approval for a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide natural gas service in and around the City of Oronogo in Jasper County, Missouri, as a further expansion of Spire’s existing certificated area. Spire further seeks permission and approval to acquire the natural gas assets of the City of Oronogo.

On August 8, 2022, the Commission directed the Staff of the Commission (Staff) to file a recommendation regarding the application, or a request for additional time, on or before September 22, 2022.

On September 22, 2022, Staff filed *Staff Status Report and Motion for Extension*, requesting that the deadline to file a recommendation be moved to on or before December 20, 2022. Spire does not object to the motion.

The Commission finds the request reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. Staff's motion for an extension of time to file its recommendation is granted.
2. Staff shall file its recommendation on or before December 20, 2022.
3. This Order shall be effective when issued.
