**ORDER GRANTING EXTENSION OF TIME**

On May 16, 2023,<sup>1</sup> Spire Missouri Inc. d/b/a Spire filed an application regarding a natural gas distribution system in Cass County, Missouri. The Commission directed a recommendation or a request for an extension of time from its Staff (Staff) no later than July 6. On July 3, Staff timely filed a request for an extension of time to submit its recommendation.

Staff requested an extension until August 8 due to outstanding data requests and time to analyze such data request answers. No party filed a response to the extension request.<sup>2</sup>

The Commission finds the request reasonable and will grant the unopposed extension.
