**RE: Notice of Transfer of Video Service Authority from  
Galva Cable Company, LLC to Skitter, Inc.**

Dear Judge Woodruff:

Pursuant to Section 67.2701 RSMo., I am writing to notify you of the transfer of Video Service Authority from Galva Cable Company, LLC (Galva) to its parent company, Skitter, Inc. (Skitter).

At the time of Galva's previous Applications for Video Service Authority from the Missouri Public Service Commission, Galva was partially owned by Skitter. In January of 2016, Skitter gained 100% ownership and total control of Galva. Additionally, Skitter is the sole owner of another cable company, Skitter Cable TV, Inc., that intends to serve some video customers in Missouri. Therefore, Skitter desires to hold a single video service authority to permit both of its subsidiaries to conduct video service operations in the State of Missouri. Skitter's corporate restructuring and the transfer of Galva's Video Service Authority will facilitate that goal and are allowed by §67.2701 RSMo.

Because this transaction is a corporate restructuring, it will be transparent to Skitter's wholesale customers (independent local exchange carriers such as GRM Networks and IAMO Telephone Company) and the ILEC's end-user subscribers. Wholesale customers have been notified, and there is no need to notify the ILECs' end-user subscribers. Skitter, Inc. registered to do business in Missouri as a foreign corporation on June 14, 2016.

Copies of this letter have been mailed to all franchise areas.

Galva/Skitter have reviewed EFIS contact information and confirmed that all contact persons are current.
