## ORDER DIRECTING NOTICE AND SETTING INTERVENTION DATE

This order provides notice of the application to establish an Infrastructure System Replacement Surcharge filed by Liberty Energy (Midstates) Corp. d/b/a Liberty Utilities (hereafter "Liberty"). This order also sets an intervention deadline.

On August 8, 2012<sup>1</sup>, Liberty filed an application with the Missouri Public Service Commission under Sections 393.1009, 393.1012 and 393.1015, RSMo Cum. Supp. 2007, requesting that the Commission authorize the company to establish an Infrastructure System Replacement Surcharge for numerous gas utility plant projects. Section 393.1015.2(3) requires the Commission to act on the application no later than 120 days after it was filed. That means the Commission must issue an order regarding the application effective no later than December 6.

Section 393.1015.1(2) and Commission Rule 4 CSR 240-3.265(7) require that the Commission publish notice of Liberty's filing. Therefore, notice of this application shall be made to the general public and those who may be interested, and a date set for intervention requests.

The Commission will require that its Data Center mail a copy of this notice to the County Commissions of the counties that Liberty serves. Also, the Commission's Public Information Office shall make notice of this order available to the media serving Liberty's service area and to the members of the General Assembly representing that service area.
