**RECONCILIATION**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and, in response to the Commission’s May 31, 2013 *Order Directing Staff To File Proposed Reconciliation* (“Order”), submits its Reconciliation and in support thereof, states as follows:

1. The Commission’s Order directed Staff to file the reconciliation required by Section 386.420.4, RSMo (Supp. 2012), which requires in pertinent part “...a detailed reconciliation containing the dollar value and rate or charge impact of each contested issue decided by the commission, and the customer class billing determinants used by the commission to calculate the rates and charges approved by the commission in such proceeding.”

2. Accordingly, Staff has prepared its Reconciliation consisting of three pages attached hereto as Appendix A. The first page shows the change in the ISRS amount of \$1,741,740 that was approved by the Commission in this case, effective May 15, 2013, and how that amount was applied to ISRS charges in each of the four MGE customer classes. The second page shows the ISRS charges that were in effect in each rate class before the change in ISRS rates was approved in this case. The third page shows the difference in ISRS charges by rate class from the charges

that were in effect before this case (October 3, 2012 through May 14, 2013) and the change in ISRS charges that were approved by the Commission in GO-2013-0391 that became effective May 15, 2013.

**WHEREFORE** Staff prays the Commission will accept its Reconciliation as submitted herein.


