STAFF RECOMMENDATION ON COMPLIANCE TARIFF FILING

COMES NOW the Staff of the Missouri Public Service Commission and pursuant to the Commission’s November 12, 2015 *Report and Order* (“Order”) submits its *Staff Recommendation on Compliance Tariff Filing* to the Commission as set forth in detail in the attached appendix, and in support respectfully states as follows:

1. The Commission’s Order issued on November 12, 2015, ordered Missouri Gas Energy (“MGE”), an operating unit of Laclede Gas Company (“Laclede”), to file a tariff sheet in compliance with the Order no later than November 13, 2015. The Order also ordered Staff to file a recommendation as to whether the tariff sheet is in compliance with the Order no later than November 16, 2015.

2. On November 13, 2015, MGE filed a tariff sheet with the Commission which bears a proposed effective date of December 13, 2015. In its transmittal letter accompanying the tariff sheet MGE requested the tariff sheet be made effective December 1, 2015.

3. Staff’s recommendation is attached hereto as Appendix A and is incorporated herein by reference. As reflected in the attached, Staff has reviewed the tariff sheet filed by MGE on November 13, 2015, and has determined that the rates therein comply with those authorized by the Commission’s Order.

4. Staff has verified that MGE has filed its annual report and is not delinquent on any assessment. Staff is not aware of any other matter before the Commission that affects, or is affected by this filing.

WHEREFORE, Staff recommends that the Commission issue an order in this case that approves the following tariff sheet filed on November 13, 2015, to go into effect on December 1, 2015, as requested by MGE:

On November 12, 2015, the Missouri Public Service Commission ("Commission") issued a REPORT AND ORDER ("Order") directing Laclede Gas Company ("Laclede") d/b/a Missouri Gas Energy ("Company" or "MGE") to file a new tariff sheet to recover the revenue authorized in the Order no later than November 13, 2015.

On November 13, 2015, MGE filed a tariff sheet with the Commission which bears a proposed effective date of December 13, 2015. In its transmittal letter accompanying the tariff sheet MGE requested the tariff sheet be made effective December 1, 2015.

In its Order, the Commission directed the Staff to file its recommendation no later than November 16, 2015. This filing is Staff's recommendation.


