MOTION FOR EXPEDITED TREATMENT

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE) and for its Motion for Expedited Treatment, states as follows:

1. Concurrent with this filing, AmerenUE is filing tariff sheets to amend its electric tariff sheets, specifically PSC. Mo. No. 1, Sheets No. 7, 8 and 11-17.
2. The changes to these sheets allow AmerenUE to implement the new Missouri net metering law, called the "Net Metering and Easy Connection Act," which has an effective date of January 1, 2008. 386.890 RSMo (Cum. Supp. 2007).
3. AmerenUE currently has a net metering tariff, but it does not comply with the new law. AmerenUE requests this tariff be approved with an effective date of January 1, 2008 (or as soon after as possible) to conform the tariff to the law. AmerenUE also requests that the Commission waive its net metering regulations, 4 CSR 240-20.065, as the Commission's regulations have not yet been modified to reflect the changes made to Missouri law.
4. This change will have no negative effect on AmerenUE customers.
5. This pleading has been filed as soon as practical after the decision to seek this change was made.

WHEREFORE, for the reasons stated herein, AmerenUE respectfully requests that the Commission waive the requirements of 4 CSR 240-20.065 and approve the tariff sheet filed herewith to take effect on January 1, 2008, or as soon after as is possible.
