2	A. Joe Gassner, Missouri Department of Economic Development, Division of Energy, 301 West

4	Q. Have you previously filed testimony in this case?

7	A. I am testifying on behalf of the Division of Energy (DE), an intervenor in these proceedings.
8	Q. What is your position with the Missouri Division of Energy?
9	A. I am the director of the Weatherization Program in the Division of Energy, which is
10	responsible for administering the Missouri Low Income Weatherization Assistance Program.
11	Q. Please describe your educational background and business experience.
12	I earned a Bachelor of Science degree in Wildlife Conservation and Management from
13	Southwest Missouri State University in 1986. I have been in my current position with the
14	Division of Energy since 2006. Other employment history includes working with the
15	Missouri Department of Natural Resources from 1991 to 2013 as a District Coordinator (two
16	years) and Environmental Specialist (14 years), working with the Osage County Soil and
17	Water Conservation District from 1990-1991 as a District Technician, and working with the
18	Missouri Department of Conservation from 1986 to 1989 as a Fisheries and Wildlife

20	II. <u>PURPOSE AND SUMMARY OF REBUTTAL TESTIMONY</u>
21	Q. What is the purpose of your rebuttal testimony in these proceedings?

23		Missouri Public Service Commission Staff (Staff) witness Kory Boustead regarding a low
24		income weatherization program for Summit Natural Gas of Missouri, Inc. (SNG).
25		III. LOW INCOME WEATHERIZATION ASSISTANCE
26	Q.	What is Staff's position regarding a SNG low-income weatherization program?
27	Α,	Staff witness Kory Boustead states that:
28 29 30 31 32 33 34 35 36 37 38		"Staff recommends the Commission authorize a natural gas energy efficiency program and a low income customer weatherization program that will be ratepayer funded through a regulatory asset account The funds for the low income customer weatherization program would be administered by the Department of Economic Development, Division of Energy (DE) in conjunction with the federal and state funds they administer for the weatherization of homes of low income Missouri families. The DE low income weatherization has demonstrated an ability to effectively weatherize homes of low income families in Missouri and the Commission has been authorizing ratepayer funded low income customer weatherization for twenty years."
39	Q.	Does DE agree with the Staff's position regarding administering an SNG low-income
40		weatherization program?
41	A.	DE agrees with Staff that the Commission should authorize a low-income weatherization
42		program and ratepayer funding. DE witness John Buchanan will address the method of rate
43		recovery recommended by DE. We also agree that DE could effectively administer the
44		weatherization program. DE is willing to take on these additional duties with a provision for
45		DE to recover its administrative and monitoring expenses incurred in performing these
46		duties.
47	Q	. What level of funding is needed to compensate DE for administration and monitoring of
48		an SNG LIWAP program?

A. The purpose of my rebuttal testimony is to respond to the direct testimony filed by the

49 A. The costs DE incurs should be covered by allowing up to 5 percent of the weatherization

- 50 fund for DE administration and monitoring. This level of funding for administration and
- 51 monitoring is within U.S. Department of Energy Low Income Weatherization Assistance
- 52 Program guidelines found in 10 CFR 440.18(e)

53 Q. What authorization does DE have to receive and/or expend these funds?

- 54 A. DE is advised by legal counsel that Section 640.676, RSMo, authorizes DE to receive/and or
- 55 expend these funds.

62 2. The director is authorized to negotiate agreements for the department to act in an
63 administrative or monitoring capacity for an energy conservation project funded in part or
64 in full by another source. The department may establish reasonable fees such as, but not
65 limited to, application and processing fees to cover the costs of such administrative or
66 monitoring role.

- 67 I am further advised by counsel that, pursuant to sections 26.500-26.540 RSMo, the
- 68 Governor issued Executive Order 13-03. This Order, effective August 29, 2013,
- 69 transferred "all authority, powers, duties, functions, records, personnel, property, contracts,
- 70 budgets, matters pending, and other pertinent vestiges of the Division of Energy from the
- 71 Missouri Department of Natural Resources to the Missouri Department of Economic
- 72 Development...." So, with its move to the Department of Economic Development, DE
- retains all the authority it had under the Department of Natural Resources, including the
- 74 ability to administer weatherization funding.

75 Q. Please describe DE's weatherization administrative and monitoring functions.

76	A. For low income weatherization assistance funds that DE currently administers on behalf of
77	Ameren (natural gas and electric), Liberty and Laclede, the utilities make a single annual
78	payment to the Missouri Environmental Improvement and Energy Resources Authority
79	(EIERA). Then DE enters into subgrant agreements with community action agencies and
80	other subgrantees, as applicable, within the utility's service area, based on budgets provided
81	by the agencies. Technical and fiscal training for the subgrantees' staff is provided as needed.
82	Once weatherization work is completed on a home, DE conducts a desk audit of the
83	reimbursement request from the subgrantee and processes it for payment. In addition, a
84	sampling of homes is monitored by on-site inspection to verify that weatherization measures
85	have been installed and are operating properly. Fiscal monitoring is performed through both
86	desk reviews and on-site review of client files, invoices, procedures manuals and other
87	documentation.

100 Q. Do you have a specific recommendation for the level of funding for an SNG low income

101 weatherization program?

- 102 A. The DE recommends an initial annual funding level of \$30,000 to support a low income
- 103 weatherization assistance program. As Missouri's LIWAP Director, it is my opinion that to
- 104 effectively implement the SNG low income weatherization program would require an
- 105 investment of \$30,000; a lower level of funding could possibly compromise the viability of
- 106 the SNG weatherization program.
