On July 2, 2007, Union Electric Company d/b/a AmerenUE (AmerenUE or Company) of St. Louis, Missouri, filed with the Commission five (5) tariff sheets with an effective date of October 1, 2007, in response to the Commission's Order Establishing Case To Consider Industrial Demand Response Program Tariff. This case is a "spin-off" from AmerenUE's last general rate case, Case Number ER-2007-0002, as described in the Commission's Report and Order issued on May 22, 2007. In its Order Establishing Time To File Recommendation, the Commission ordered the Staff to file its recommendation regarding AmerenUE's tariff filing by August 31, 2007. This is the Staff's recommendation.

The Commission's Energy Department Staff (Staff) has reviewed the proposed tariff sheets and has participated in discussions/negotiations among the parties. As of this date, the parties have not all been able to agree to all of the elements of the Industrial Demand Response (IDR) Pilot Program. Nevertheless, the Staff believes that progress toward an agreement is being made and, given more time, an agreement is possible. Having missed the opportunity to have an IDR Pilot Program in place for the summer of 2007, there should be ample time to work out an agreement to put in place for the summer of 2008

The Staff, however, is concerned that in the event that no agreement is reached, there will be no IDR Pilot Program. Approval of these tariff sheets would not preclude the Commission from modifying the tariff sheets at a later date, if agreement among the parties is reached, or the Commission decides to impose the revisions urged by the Missouri Energy Group (MEG) in Case No. ER-2007-0002. These tariff sheets incorporate some, but not all of MEG's suggestions. Therefore, in an effort to increase the demand response offerings in the State of Missouri, Staff recommends that the Commission approve the following tariff sheets to become effective on October 1, 2007, as proposed by the Company on July 2, 2007:
