APPLICATION OF GENERAL MILLS, INC. TO INTERVENE

COMES NOW General Mills, Inc., by and through counsel, pursuant to 4 CSR 240-2.075, and applies to intervene and become a party in the above-referenced case, and in support of its Application to Intervene states as follows:

- 1. General Mills, Inc. ("Intervenor") is a corporation authorized to do business in Missouri, with facilities in the City of Joplin, Jasper County, Missouri, and receives its electric service from Empire District Electric Company ("Empire").
- 2. General Mills, Inc. is a major user of electric power. Intervenor's interest in proceedings affecting the rates for electric service from Empire has been previously recognized by the Missouri Public Service Commission, in permitting other major power users to intervene in prior Empire and other electric utility rate-related proceedings.
- 3. On October 1, 20007, Empire filed proposed tariffs reflecting an annual revenue increase of over \$34 million, an increase of over 10%.
- 4. On October 3, 2007, the Missouri Public Service Commission issued an Order suspending the proposed rates and tariffs and directing an investigation of the proposals, setting an intervention deadline, scheduling a hearing, and setting a pre-hearing conference. This Application to Intervene is timely under that Order.

5. Intervenor states, pursuant to 4 CSR 240-2.075(2), that it is opposed to any unreasonable or unjust increase in electric rates that would create financial hardship or undue discrimination to General, Mills Inc. This is unsure of the position Intervenor will take with respect to the requests contained in Empire's filing.

6. Intervenor's interest, as a major electrical power user, is different from that of the general public and such interest may be adversely affected by any final order arising from this case.
