**NOTICE OF HEARING SCHEDULE MODIFICATION**

Comes now the Staff of the Missouri Public Service Commission (“Staff”) and advises the Missouri Public Service Commission (“Commission”) of the following hearing schedule modification, which all parties have been apprised of and have had an opportunity to have input in as the matter has developed over a number of days.

1. Due to availability / scheduling problems, the International Brotherhood of Electrical Workers (“IBEW”) and International Union of Operating Engineers (“IUOE”) – AFL-CIO (“Unions”) witnesses, originally scheduled for Tuesday, November 25 have been rescheduled for Tuesday, December 2 and Wednesday, December 3. Mr. Michael Datillo (IBEW Local 1455) will testify on the afternoon of December 2; Mr. David Desmond (IBEW Local 2), Mr. Michael Walter (IBEW Local 1439), and Mr. Donald Giljum (IUOE Local 148) will testify as early as possible on the morning of December 3. Mr. Mark Birk (AmerenUE) and Mr. Ronald Zdellar (AmerenUE) also will testify on the morning of December 3. Messrs. Datillo, Desmond, Walter, and Giljum have direct testimony filed, and Messrs. Birk and Zdellar have responsive testimony filed. AmerenUE has a Motion To Strike Portions Of Direct Testimony Of Witnesses Datillo, Desmond, Walter, And Giljum filed. It is the Staff’s understanding that Counsel for the Unions will be filing a responsive pleading to the AmerenUE Motion To Strike.

Wherefore the Staff files Notice of a modification of the hearing schedule respecting the issues raised by the International Brotherhood of Electrical Workers and International Union of Operating Engineers – AFL-CIO, as indicated in paragraph 1 above.
