STAFF NOTIFICATION OF NO KNOWN STAFF TRUE-UP ISSUES

Comes now the Staff of the Missouri Public Service Commission (Staff), through the General Counsel's Office, and files the instant pleading stating that to the knowledge of the Staff, the Staff has no true-up issues with Union Electric Company, d/b/a AmerenUE (AmerenUE) in the instant rate increase case. In this regard, the Staff states as follows.

1. The Missouri Public Service Commission (Commission), in its May 29, 2008 Order Adopting Procedural Schedule And Establishing Test Year, set (a) December 23, 2008 for the filing of True-up Direct Testimony, (b) December 30, 2008 for the filing of True-up Rebuttal Testimony, (c) January 5, 2009 for the filing of a True-up Reconciliation, and (d) January 6-7, 2009 for a True-up Hearing, if necessary.

2. On December 22, 2008, AmerenUE filed the True-up Direct Testimony and Schedules of Gary S. Weiss. The Staff is reviewing this filing of AmerenUE.

2. The Staff anticipates that a True-up Hearing will not be necessary, but recommends that the Commission take no action respecting the scheduled True-up Hearing until after December 30, 2008, the True-up Rebuttal Testimony filing deadline.

3. The Staff notes that toward the end of the hearing day on December 10, 2008, the Staff distributed at the hearing an updated iteration of the Staff's Reconciliation. The Staff

intends to file with the Commission, and serve upon the parties, a True-up Reconciliation on January 5, 2009, or sooner if possible.

Wherefore the Staff files the instant pleading stating that to the knowledge of the Staff, the Staff has no true-up issues with Union Electric Company, d/b/a AmerenUE (AmerenUE), the Commission should take no action until after December 30, 2008 respecting the True-up Hearing scheduled for January 6-7, 2009, and the Staff intends to file with the Commission a True-up Reconciliation on January 5, 2009, or sooner if possible..
