LIFELINE SERVICE

General Regulations A.

- Lifeline service is available to qualifying low-income subscribers for single party 1. residence service.
- Lifeline service is a reduction in the monthly local service charges normally paid by qualifying low- income consumers. Eligible Lifeline subscribers will receive: 2.

- Federal Lifeline support of \$9.25, Additional Missouri8 Universal Support up to \$3.50, as long as the total amount of * items "a" and "b" do not exceed the sum of the Federal Subscriber Line Charge and the recurring charges for basic b. local telecommunications services.
- 3. Lifeline will not be furnished on a Foreign Exchange service.
- 4. Lifeline service shall not be disconnected for non-payment of toll charges.
- Toll blocking provides a means of restricting access to the Long Distance Message Telecommunications Network. Toll blocking for the purposes of lifeline service will restrict 1+, 0+ and 0- (operator handled) calls. 5.
 - If the customer chooses "toll blocking" the company will not charge a service a. deposit.
 - Toll blocking is offered to Lifeline subscribers at no charge. h.
- Eligible Lifeline customers are exempt from the Access Recovery Charge (ARC) 6. effective July 1, 2012.*

В. **Eligibility Requirements**

- 1. An applicant must meet all of the following criteria in order to qualify for Lifeline Service.
 - To qualify for Lifeline or Missouri Universal Service Fund Low-income assistance the consumer must participate in one of the following programs:*

 - Medicaid Food Stamps
 - Food Stamps
 Supplemental Security Income (SSI)
 Federal public housing assistance
 Low Income Home Energy Assistance Program
 Temporary Assistance to Needy Families
 National Free Lunch Program; or
 The customer's income, as defined in 47 CFR Section 54.400(f), must be at or below 135% of the Federal Poverty Guidelines.* b.
- 2. All Lifeline customers as of June 1, 2012 must certify with the Company that they are still eligible for Lifeline support by December 31 each year. Customers may certify in person, over the phone, or in writing. Customers will not be required to provide verifying documentation.*
- The premises at which the residence service is requested must be the applicant's 3. principal place of residence.

1. **Missouri USF Low-Income Assistance**

- **General** A low-income customer is any customer who requests or receives residential essential local telecommunications service and who has been certified by the Department of Social Services (DSS) as economically disadvantaged.  - Single line residential service, including touch-tone dialing and any applicable mileage or zone charges
 - Access to local emergency services, including, but not limited to, 911 service established by local authorities 2.

 - Access to basic local operator services Access to basic local directory assistance 4.

 - Standard intercept service Equal access to Inter-Exchange Carriers consistent with rules and regulations 6.

 - One (1) standard white pages directory listing Toll blocking or toll control for qualifying low-income customers
- D. **Support Amount**- Customers eligible under the established criteria can receive a discount from their bill for essential local telecommunications service equal to the amounts approved by the Missouri Public Service Commission and the Federal Communications Commission. The amount of combined federal and state lifeline support for any customer will not exceed the sum of the federal Subscriber Line Charge (SLC) and the recurring charges for essential local telecommunications services (including the basic service rate, Touch-Tone calling charge, extended area service additive, and mileage additives, if any).

2. Missouri USF Disabled Assistance

General- A disabled customer, or a dependent, is a customer who requests or receives residential essential local telecommunications service, as defined in section 1(c) of this tariff, and meets the eligibility requirements set forth in this tariff.
