On May 10, 2021,<sup>1</sup> the Commission conducted a procedural conference. Subsequently, the Commission has set and, in order to allow the Spire Missouri, Inc. d/b/a Spire and the Commission Staff (the "Parties") to continue their possible settlement discussions, has extended deadlines for the parties to file a proposed procedural schedule, status report or other pleading. Most recently, on June 28 the Commission ordered the parties to file such pleadings no later than July 12. On July 12, the parties filed a Joint Status Report stating they continued to discuss the matter and hoped settlement would be possible. They asked the Commission to order them to file either a status report or other pleading no later than August 2. The Commission will grant the request.

#### THE COMMISSION ORDERS THAT:

1. The parties' joint request that the Commission order them to file either a status update or other pleading no later than August 2, 2021 is granted.
