On May 10, 2021,¹ the Commission conducted a procedural conference. Subsequently, the Commission has set and, in order to allow the Spire Missouri, Inc. d/b/a Spire and the Commission Staff (the “Parties”) to continue their possible settlement discussions, has extended deadlines for the parties to file a proposed procedural schedule, status report or other pleading. Most recently, on August 2, the Commission ordered the parties to file such pleadings no later than September 1. On September 1, the parties filed a Joint Status Report stating they continued to discuss the matter and asked the Commission to order them to file either a status report or other pleading no later than October 1. The Commission will grant the request.

THE COMMISSION ORDERS THAT:

1. The parties’ joint request that the Commission order them to file either a status update or other pleading no later than October 1, 2021 is granted.
2. No later than October 1, 2021, the Commission Staff and Spire Missouri, Inc. d/b/a Spire shall file a status update or other pleading.
