**STAFF RECOMMENDATION TO APPROVE TARIFFS**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, and files its *Staff Recommendation to Approve Tariff Sheets* and states as follows:

1. On February 3, 2023, Spire Missouri, Inc. d/b/a Spire (“Spire Missouri”) filed tariffs in Tariff Tracking No. JG-2023-0141 that Spire Missouri stated in its accompanying response and transmittal letter are intended to reflect the Commission’s *Order Approving Acquisition of Assets and Granting Certificate of Convenience and Necessity* issued on January 25, 2023. The tariffs bear an effective date of March 6, 2023.
2. Staff has reviewed the tariff sheets filed in Tariff Tracking No. JG-2023-0141 and recommends the Commission approve them or allow them to go into effect for service:


