## Submission of Additional Information Pertinent to this Case

This document is submitted to the Public Service Commission of the State of Missouri in response to Data Information Requests made by Union Electric Company d/b/a AmerenUE in their Answer to the Complaint filed by Complainants in Case No. GC-2007-0350.

Five documents are attached to this filing. Specifically they are:

- 1. Account activity report from Intercounty Electric Cooperative detailing the electricity consumption history for the Complainants residence at 10600 Bennish Lane. The account activity starting in Mar 2006.
- 2. Account history with MFA detailing the liquid propane fuel account activity for the Complainants residence at 10600 Bennish Lane. The account activity shows that the contracts were being put in place as early as November, 2005. This should not be taken to indicate that the Complainants took residence in that location at that time. In fact, the first delivery made to that account was not until April 11, 2006.
- 3. A letter from Mr. Joshua Dachsteiner who personally assisted the Complainants in moving their belongings to their new residence. In this letter, he attests to the fact that the Complainants did not vacate the 403 E. 10<sup>th</sup> St. residence until April 1, 2006.
- 4. A page taken from a U.S. Government Standard Form 85, OPM Security Clearance Application, where it is stated that the Complainant lived at the 403 E. 10<sup>th</sup> St. location until April 1, 2006 and then took up residence at the 10600 Bennish Lane location from April 1, 2006 to the present date. This document is used to grant the Complainant a high level Secret Security Clearance, and, due to the Complainants line of work for the Department of the Army, is evaluated at very high levels of the Government before granting this type of Clearance.
- 5. A letter from Fidelity Communications (Cable TV, Internet, and Telephonic Service Provider) which provides service to the residence at 10600 Bennish Lane. This letter details that the prior residents at that residence maintained

their account until they requested the services to be disconnected on March 23, 2006. This would seem to corroborate the Complainants claim that they did not move into that location until April 1, 2006 as the prior residents were still there until the end of March.

If there is any further information requested to further corroborate these statements, please feel free to ask.
