ORDER OF RULEMAKING

By the authority vested in the public service commission by sections 386.040, 386.250, and 392.200, RSMo, the commission adopts a rule as follows:

4 CSR 240-32.180 Definitions - Caller Identification Blocking Service is adopted.

A notice of proposed rulemaking containing the text of the proposed rule was published in the *Missouri Register* on December 15, 2003 (28 Mo Reg 2221-2222). No changes have been made in the text of the proposed rule, so it is not reprinted here. This proposed rule becomes effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: The public service commission received comments from the office of the public counsel and from the staff of the commission, both expressing support for the rule.
