 - a) Submission of a Joint Stipulation of Facts;
 - b) Submission of the List of Issues, Proposed Order of Hearing Components (opening, witnesses, cross-exam, etc.), and Position Statements at least one calendar week in advance of the evidentiary hearing;
 - c) Submission of exhibit lists to the regulatory law judge; and
 - d) Account for a ten-business-day turnaround time for transcripts.
