On August 31, 2021, a requested status report was jointly filed by Spire Missouri Inc. and the Staff of the Missouri Public Service Commission (Staff). The filing indicated that the parties continue to believe a settlement may be possible with additional time. The parties requested an additional thirty days to discuss possible resolution.

The Commission finds that the request for additional time is reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The parties shall file a status report, a joint proposed procedural schedule (to the extent the parties can agree) or a settlement on or before October 1, 2021.
