

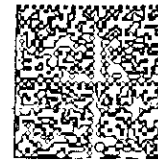

On October 19, 2009, counsel for Trigen-Kansas City Energy Corporation ("Trigen"), the law firm of Stewart & Keevil, L.L.C.,<sup>1</sup> filed a motion requesting leave to withdraw from representation of Trigen in the above captioned matter. Counsel represents that the law firm has closed and Trigen is now being represented by the law firm of Bryan Cave L.L.P.<sup>2</sup>

Commission Rule 4 CSR 240-2.040(6) provides that an attorney may withdraw from representing a party before the Commission only by leave of the Commission. Because Trigen has secured other counsel, the Commission will allow the law firm of Stewart & Keevil, L.L.C. to withdraw.

**THE COMMISSION ORDERS THAT:**

1. The law firm of Stewart & Keevil, L.L.C. is granted leave to withdraw as counsel for Trigen-Kansas City Energy Corporation.


