### **CORRECTED NOTICE OF APPLICATION, AND ORDER DIRECTING STAFF TO FILE RECOMMENDATION AND SETTING DEADLINE FOR INTERVENTION**

The Commission is directing its staff to file a recommendation on the application of Missouri Gas Utility, Inc., ("MGU") described in the title of this action ("application"), setting a deadline for motions to intervene, and giving notice of the application.

MGU filed the application on July 9, 2009. The application seeks the Commission's permission and approval to construct gas facilities and provide gas service. Legal descriptions ("proposed service area") locating such proposed construction and service appear in the application's paragraph 8 and appendix A, and the names of ten persons residing or owning land in the proposed service area appears in paragraph 13.

The statutory requirement of a "due hearing"<sup>1</sup> allows the Commission to grant an unopposed application without conducting a hearing.<sup>2</sup>

  2. The Commission's information officer shall make this notice and order available to the:
    - a. members of the Missouri General Assembly whose districts include the proposed service area described in the body of this order, and
    - b. media serving the proposed service area.
  3. Any motion for intervention is due no later than August 13, 2009. Any person filing such a motion shall send the motion to:

4. Staff shall file its recommendation as to the application of Missouri Gas Utility, Inc., that is the subject of this action no later than October 13, 2009.
