On August 23, 2018, Summit Natural Gas of Missouri, Inc. (Summit), a successor to Missouri Gas Utility, Inc. and Southern Missouri Gas Company, L.P. d/b/a Southern Missouri Natural Gas, filed tariff sheets (with a proposed effective date of September 22, 2018) purporting to comply with the Commission's August 15, 2018 *Order Granting Certificate of Convenience and Necessity and Granting Waivers*. The Commission directs the Staff of the Missouri Public Service Commission to file a recommendation and sets a date for responses to Staff's recommendation or any other responses to the tariff to be filed as set out below.

### THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file its recommendation regarding Tariff File No. YG-2019-0024 no later than August 31, 2018.
2. Any responses to the Staff of the Missouri Public Service Commission's recommendation or to Tariff File No. YG-2019-0024 shall be filed no later than September 6, 2018.

3. This order shall be effective when issued.
