STAFF'S SUBSTITUTE REVISED TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), through the undersigned counsel, and recommends that the Commission approve the proposed revised tariff sheets Spire Missouri Inc., d/b/a Spire ("Spire" or "Company") filed July 21, 2022, respectfully states as follows:

- 1. On November 12, 2021, the Commission issued its *Order Approving Stipulation and Agreement and Granting Certificate of Convenience and Necessity* ("Order") granting Spire a Certificate of Convenience and Necessity ("CCN") to construct, install, own, operate, maintain and otherwise control and manage a natural gas distribution system to provide gas service in Buchanan County, Missouri. Paragraph 6 of the order states that, "Spire shall file an updated tariff sheet to incorporate the legal description of the subdivision location upon Commission approval of this agreement."
- 2. On June 30, 2022, the Commission issued its *Order Directing Filing of a Status Report* ordering Spire to file a report on the status of compliance with Paragraph 6 of the November 12, 2021 Order no later than July 15, 2022.

- 3. Spire filed its *Status Report* on July 15, 2022. In the *Status Report*, Spire indicated that it will update its tariffs on record with the Commission after filing the Status Report.
- 4. On July 19, 2022, Spire filed a revised tariff sheet in compliance with the Commission's November 12, 2022 Order. On July 21, 2022, Spire filed a substitute revised tariff sheet with an effective date of August 19, 2022.
- 5. Following Staff's review, Staff finds that the substitute revised tariff sheet filed on July 21, 2022, is in compliance with the Commission's November 12, 2021 Order. Staff *recommends approval* of:

1st Revised Sheet No. 21.1, Cancelling P.S.C. MO. No. 9 Original Sheet No 21.1

WHEREFORE, Staff respectfully requests that the Commission issue an order approving Spire's proposed substitute revised tariff sheet filed on July 21, 2022, with an effective date of August 19, 2022.
