ORDER DIRECTING EXPEDITED STAFF REVIEW

On August 23, 2023,¹ the Commission issued its *Order Approving Application and Granting a Certificate of Convenience and Necessity* (Order) granting Spire Missouri Inc. d/b/a Spire a certificate of convenience and necessity (CCN) as an expansion of its existing natural gas distribution service area in Cass County, Missouri.

On August 24, Spire filed a tariff sheet purporting to be in compliance with the Commission’s Order. That tariff sheet was assigned Tracking No. JG-2024-0025 and has a proposed effective date of September 23.

The Commission will direct its Staff to review the tariff sheet and provide its recommendation. The Commission will also set a time for other responses.

THE COMMISSION ORDERS THAT:

1. No later than September 12, Staff shall file a recommendation as directed in the body of this order or a statement of when it expects to file its recommendation.
2. No other party is required to respond, but any party that wishes to respond to the tariff filings shall do so no later than September 12.
3. This order shall be effective when issued.
