SUBJECT: Staff Recommendation on Southern Missouri Gas Company, L.P.'s Optional PGA Filing Effective February 1, 2010

DATE: January 22, 2010

On January 19, 2010, Southern Missouri Gas Company, L.P. (SMGC or Company) d/b/a Southern Missouri Natural Gas of Mountain Grove, Missouri, filed a tariff sheet with a proposed effective date of February 1, 2010. On January 22, 2010, SMGC filed a substitute tariff sheet at the request of the Energy Department – Tariffs/Rate Design Staff (Staff). The tariff sheet was filed to reflect changes in SMGC's Purchased Gas Adjustment (PGA) factor as the result of estimated changes in the cost of natural gas. SMGC also filed a Request For Variance From Tariff Provisions (Variance). This Variance is a request for the rates to go into effect on less than 10 business days notice.

The net effect of this change will increase the Total PGA factor to \$0.8020 per hundred cubic feet (Ccf) from the Total PGA factor of \$0.7200 per Ccf currently in effect. The PGA is based on sales projections for the remainder of SMGC's ACA period (February 2010 through September 2010). This represents an increase of \$0.0120 per Ccf.

Case No. GR-2010-0218, under which this change was filed, was established to track the Company's PGA factors to be reviewed in its 2009-2010 ACA filing. Case No. GR-2009-0287 was established to track the Company's PGA factors to be reviewed in its 2008-2009 ACA filing. Interim subject to refund status should be maintained pending a final Commission decisions in Case Nos. GR-2009-0287 and GR-2010-0218.

Staff has verified that the Company has filed its annual report and is not delinquent on any assessment. Staff has reviewed this filing and is not aware of any issue currently pending before the Commission that affects or is affected by this filing.

Staff has determined that the rates on the proposed tariff sheet were calculated in conformance with SMGC's PGA Clause. Staff recommends approval of SMGC's request for variance from tariff provisions, and the following tariff sheet filed on January 19, 2010, as substituted on January 22, 2010 should be approved interim subject to refund:
