ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH COMMISSION ORDER

On June 11, 2010, Union Electric Company, d/b/a Ameren Missouri filed proposed tariff sheets initiating this rate case. In order to allow time for review, the Commission suspended the proposed sheets and subsequently set this matter for hearing.

On January 19, 2011, the Missouri Public Service Commission approved a Unanimous Stipulation and Agreement settling all issues. On January 21, 2011, Union Electric Company, d/b/a Ameren Missouri filed tariff sheets intended to reflect the Agreement. The tariff sheets bear an effective date of February 20.

On January 25, the Staff of the Commission filed its memorandum informing the Commission that the tariff sheets are in compliance with the Agreement. Staff recommends that the tariff sheets be approved to become effective on February 20.

The Commission will also reject the proposed tariff sheets filed by Ameren on June 11, 2010.

THE COMMISSION ORDERS THAT:

1. The proposed tariff sheets submitted by Union Electric Company, d/b/a Ameren Missouri, under Tariff File No. YG-2010-0704 on June 11, 2010, and specifically suspended by the Commission in its Order of June 16, 2010, are rejected.
