ORDER DIRECTING NOTICE, DIRECTING FILINGS AND SETTING INTERVENTION DEADLINE

On April 17, 2015, Missouri Gas Energy ("MGE"), an operating unit of Laclede Gas Company, filed a verified application and petition to change its Infrastructure System Replacement Surcharge ("ISRS") in its Missouri Gas Energy Service Territory, pursuant to Sections 393.1009, 393.1012, and 393.1015, and Commission rules 4 CSR 240-2.060, 2.080, and 3.265. MGE also filed a *Motion for Expedited Treatment*. MGE's verified application is a re-filing of an ISRS application MGE filed on January 30, in File No. GO-2015-0179. MGE dismissed its application in File No. GO-2015-0179, by filing a *Joint Notice of Voluntary Dismissal Without Prejudice* ("Joint Notice"). The Joint Notice was the result of an agreement of the parties in that matter. MGE requests expedited treatment based on the parties' agreement to work to implement MGE's ISRS filings as soon as reasonably possible, with an anticipated Commission decision occurring by the end of May.

Section 393.1015.1(2) requires that the Commission publish notice of MGE's filing. Therefore, the Commission will give notice of this application to the general public and interested persons and set a date for intervention. The Commission's Data Center shall

mail a copy of this notice to the county commission, or equivalent governmental body, of all of the counties within MGE's gas service territory. The Data Center shall also provide a copy of this notice to the parties in MGE's most recent gas rate case, File No. GR-2014-0007. In addition, the Commission's Public Information Office shall make notice of this order available to the media serving MGE's service area and to the members of the General Assembly representing MGE's service area.

Pursuant to Commission Rule 4 CSR 240-3.265(8) and (9), MGE must file sample customer notices for the Commission's approval. The Office of the Public Counsel may file a response to those notices within ten days of their filing.

Section 393.1015.2(2) allows the Commission's Staff to examine MGE's application to change its ISRS and to submit a report of its examination no later than 60 days after the petition is filed. MGE states that under the terms of the Joint Notice, the parties agreed that since Staff previously reviewed the ISRS-eligible investments made between September 1, 2014 and February 28, 2015—the timeframe covered by the ISRS application in this matter—Staff should be able to file its recommendation in this matter within two weeks. Since the Joint Notice does not bind Staff to that schedule, the Commission will establish a deadline for Staff to file its recommendation consistent with the statute. Staff is allowed to submit its recommendation prior to the ordered deadline.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve this order upon the parties to File No. GR-2014-0007, and the County Commissions for the counties of: Andrew, Barry, Barton, Bates, Buchanan, Carroll, Cass, Cedar, Christian, Clay, Clinton, Dade, DeKalb, Greene, Henry, Howard, Jackson, Jasper, Johnson, Lafayette, Lawrence, McDonald, Moniteau, Pettis, Platte, Ray, Saline, Stone, and Vernon.

2. The Commission's Information Officer shall serve notice as set out in the body of this order.

3. Any entity wishing to intervene in this matter shall file an application to do so no later than April 30, 2015. Such applications shall be filed with the Secretary of the Missouri Public Service Commission or by using the Commission's Electronic Filing and Information System ("EFIS").

4. No later than April 30, 2015, MGE shall file sample customer notices as required by Commission Rule 4 CSR 240-3.265.

5. No later than ten days after MGE files the sample customer notices, as directed in ordered paragraph number 4, the Office of the Public Counsel may file a response to those notices.

6. No later than June 16, 2015, the Staff of the Missouri Public Service Commission shall file its recommendation in this matter.

7. This order shall be effective when issued.
