**STAFF'S RECOMMENDATION FOR APPROVAL OF TARIFF SHEET**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel and recommends that the Missouri Public Service Commission ("Commission") approve the tariff sheet submitted in Case No. GO-2015-0274. In support of this recommendation, Staff states as follows:

1. On July 1<sup>1</sup> the Commission issued an order rejecting the Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") tariff sheet filed on April 10 and authorizing Ameren Missouri to file a new tariff sheet that reflects the new under-collected amount agreed upon by Ameren Missouri and Staff.

2. On July 2 Ameren Missouri submitted a revised tariff sheet that accurately reflects the under-collected revenue amount agreed upon by Ameren Missouri and Staff and complies with the Commission Order issued on July 1. The revised tariff sheet was given tariff tracking No. YG-2016-0006 and is labeled the 7<sup>th</sup> revised tariff sheet No. 34.

3. Staff finds that Ameren Missouri's proposed tariff sheet is in compliance with the Commission's *Order Approving Infrastructure System Replacement Surcharge Reconciliation* issued in this case, and recommends that the Commission issue an order approving the proposed tariff sheet, to become effective on August 1.

**BACKGROUND**

On July 1, 2015, the Missouri Public Service Commission ("Commission") issued an *Order Approving Infrastructure System Replacement Surcharge Reconciliation* authorizing Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") to file a new tariff to recover revenues related to its Infrastructure System Replacement Surcharge ("ISRS").

On July 2, 2015, Ameren Missouri filed an ISRS compliance tariff sheet.

On July 7, 2015, the Missouri Public Service Commission ("Commission") issued an ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND SETTING DEADLINE FOR RESPONSES ("Order"). The Order set a July 13, 2015, deadline for Staff to file its recommendation concerning Ameren Missouri's filed ISRS tariff sheet.

**STAFF'S ACTION & RECOMMENDATION**

The Staff has reviewed Ameren Missouri's tariff sheet. Staff's analysis indicates that the tariff sheet filed by Ameren Missouri on July 2, 2015, complies with the Commission's July 1, 2015, 2014 Order.

The Staff has verified that Ameren Missouri has filed its annual report and is not delinquent on any assessment. The Staff is not aware of any other matter before the Commission that affects or is affected by this filing.

Therefore, Staff recommends that the following tariff sheet, as filed on July 2, 2015, be allowed to go into effect on August 1, 2015, as requested by Ameren Missouri.


