**ORDER SETTING DEADLINE FOR RESPONSE TO OPC’S MOTION  
FOR EXPEDITED TREATMENT**

On May 19, 2016, the Commission issued its *Report and Order* in File Nos. GO-2016-0196 and GO-2016-0197. On May 26, the Office of the Public Counsel (OPC) submitted applications for rehearing, which the Commission denied on June 1. On June 23, OPC filed its *Motion for Order Directing Reconciliation and Motion for Expedited Treatment*. OPC requests that Commission’s Staff be directed to file the reconciliations required by Section 386.420.4, RSMo (Cum.Supp. 2013) no later than Tuesday, June 28. OPC is requesting the expedited reconciliation deadline so that it will have an opportunity to review the reconciliations and provide comments before the July 1 deadline to file a notice of appeal of the Commission’s *Report and Order*.

The Commission will set a deadline for parties to file a response should they oppose OPC’s motion for expedited treatment.

**THE COMMISSION ORDERS THAT:**

1. Responses to OPC's *Motion for Order Directing Reconciliation* and *Motion for Expedited Treatment* may be filed no later than 9:00 a.m. on Monday, June 27, 2016.
2. This order shall be effective when issued.
