FINAL STATUS REPORT

COMES NOW Missouri-American Water Company (“MAWC” or the “Company”), and, provides the following status report to the Missouri Public Service Commission (“Commission”):

1. On November 20, 2003, the Commission issued its Report and Order in this matter in which, among other things, it approved the joint application for sale of assets filed by Warren County Water & Sewer Company and MAWC (“with the exception of the request for ratemaking treatment and with the conditions specified”). Subsequently, on July 20, 2004, the Commission issued its Order Approving Sale as Modified.


2. MAWC hereby informs the Commission that MAWC closed this transaction on August 26, 2004, and is currently operating the Warren County assets. Furthermore, MAWC is working diligently to bring the service and reliability of this system up to MAWC’s standards.

3. MAWC has been directed to file with the Commission tariff sheets adopting the same rates, terms and conditions as in the currently effective tariffs of Warren County Water & Sewer Company. Accordingly, MAWC has filed today a title sheet and adoption tariff to adopt the tariffs of Warren County Water & Sewer Company as to the water system tariffs. Sewer tariffs will be filed on Monday, as EFIS does not recognize MAWC’s counsel as being authorized to file the sewer

tariffs.

WHEREFORE, the Company respectfully requests the Commission accept this Final Status Report.
