MGE's MOTION TO SET PROCEDURAL SCHEDULE

COMES NOW Missouri Gas Energy, a division of Southern Union Company ("MGE" or "Company"), and states the following to the Missouri Public Service Commission ("Commission") as its Motion to Set Procedural Schedule:

1. The parties attempted to simplify this case by pursuing a stipulation of facts that would have eliminated (or, at least shortened) an evidentiary hearing. Unfortunately, these efforts have been unsuccessful as the parties have been unable to reach unanimous agreement on such a stipulation.

2. Accordingly, it will be necessary to set a procedural schedule in order to move this case to conclusion. MGE moves the Commission to issue an order setting such a schedule and further proposes that the procedural schedule be set as follows:


Direct Testimony (Applicant)	April 10, 2008
Rebuttal Testimony (Staff/OPC)	May 23, 2008
Surrebuttal Testimony (All Parties)	June 13, 2008
Settlement Conference	June 19-20, 2008
List of Issues, Order of Cross, Order of Witnesses	June 27, 2008
Parties' Position Statements	July 8, 2008
Evidentiary Hearing	July 14-15, 2008

3. MGE plans to file its direct testimony on April 10, 2008, as would be called for by this proposed schedule.

4. Counsel for the Staff of the Commission indicates that the Staff concurs with the procedural schedule proposed herein.

WHEREFORE, MGE moves the Commission to issue an order setting the above procedural schedule.
