## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: December 10, 2014 Effective Date: December 20, 2014 On November 14, 2014, the Staff of the Missouri Public Service Commission filed a motion requesting Farm Bureau Connection ("Farm Bureau") certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XN-2006-0191, the Commission granted Farm Bureau a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Staff unsuccessfully attempted to contact Farm Bureau. Staff noted that Farm Bureau has failed to file an annual report or pay any assessment to the Commission. Staff believes the company is no longer providing service in Missouri and requested the Commission cancel Farm Bureau's certificate of service authority and the company's accompanying tariff.

On November 17, 2014, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than December 1, 2014. No objections or requests for a hearing were filed. The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Farm Bureau Connection, shall be canceled.

### **IT IS ORDERED THAT:**

1. The certificate of authority to provide interexchange telecommunications services granted to Farm Bureau Connection, in File Number XN-2006-0191, is canceled.

- 2. Farm Bureau Connection's tariff, P.S.C. Mo No. 1, is canceled.
- 3. This order shall become effective on December 20, 2014.
- 4. This case may be closed on December 21, 2014.
