On December 15, 2021, the Commission's Staff filed its Recommendation Regarding the 2019-2020 Actual Cost Adjustment (ACA) Filing of Summit Natural Gas of Missouri, Inc. (Summit). Staff proposes adjustments to the ending ACA balances as of August 31, 2020, as shown in the "Staff Recommended Ending Balances" column of the table in the Recommendations section of Staff's *Memorandum*, filed December 15, 2021, and recommends the Commission order Summit to respond to those recommendations within 30 days.
