# ORDER DIRECTING SPIRE RESPONSE AND SETTING TIME FOR OTHER RESPONSES

On May 27, 2022, the Commission's Staff (Staff) filed a recommendation addressing Spire Missouri, Inc. d/b/a Spire's 2019-2020 Actual Cost Adjustment (ACA) filing for its Spire East system. Staff reviewed Spire's gas purchasing practices to evaluate the prudence of the company's purchasing decisions and also examined the prudence of costs related to the Spire STL Pipeline. Based on its review, Staff recommends the Commission make adjustments to Spire's ending ACA balances, and issue an order establishing those balances.

The Commission will direct Spire to submit a response to Staff's recommendation.

The Commission will also set a time for any other responses to Spire's ACA filing or Staff's recommendation

# THE COMMISSION ORDERS THAT:

1. Spire shall file a response to Staff's recommendation no later than July 11, 2022.

2. Any other entity wishing to comment on Staff's recommendation or Spire's response shall do so no later than July 18, 2022.
