ORDER APPROVING TARIFF

On August 29, 2022, Empire Gas filed Tariff Tracking No. YG-2023-0045, with a September 28, 2022 effective date. Empire Gas filed this tariff to correct an error and conform the tariff with the Commission-approved settlement. Empire Gas then filed substitute tariffs on September 2, 2022

On September 7, 2022, Staff filed its Recommendation. Staff recommends the Commission approve the tariff or allow it to go into effect. The Commission received no other responses to the tariff filing or Staff's Recommendation.

The Commission reviewed the tariff filing and Staff's Recommendation, and determines that the filings comply with the Commission's previous order. Thus, the Commission will approve the tariff.

1. The tariff sheets in Tariff No. YG-2023-0045, issued August 29, 2022, as substituted on September 2, 2022, are hereby approved to become effective on September 28, 2022.
