ORDER DIRECTING FILING OF A JOINT PROPOSED PROCEDURAL SCHEDULE OR A STATUS REPORT

On December 14, 2022, the Staff of the Commission (Staff) filed its recommendation regarding the 2020-2021 Actual Cost Adjustment (ACA) filing made by Summit Natural Gas of Missouri, Inc. (Summit) on November 4, 2021. On December 19, 2022, the Commission directed Summit to respond to Staff's recommendation. On January 18, 2023, Summit filed its *Response to Staff's Recommendation and Memorandum*.

On March 1, 2023, Staff filed a reply to Summit's *Response* in which it informed the Commission that discussions were ongoing between Summit and Staff regarding Staff's proposed adjustments to Summit's ACA. Staff suggested an April 10, 2023 deadline to file either a proposed procedural schedule or a status report as to the progress of discussions.

The Commission will follow Staff's suggestion.

THE COMMISSION ORDERS THAT:

1. No later than April 10, 2023, Staff shall file either a joint proposed procedural schedule or a status report as to the progress of discussions regarding Staff's proposed adjustments to Summit's ACA.

2. This order shall be effective when issued.
