7	Q. Please state your name and business address.
8	A. Cary G. Featherstone, Fletcher Daniels State Office Building, 615 East 13 th
9	Street, Kansas City, Missouri.
10	Q. By whom are you employed and in what capacity?
11	A. I am a Regulatory Auditor with the Missouri Public Service
12	Commission ("Commission").
13	Q. Are you the same Cary G. Featherstone who filed direct testimony in
14	this proceeding?
15	A. Yes, I am. I contributed to the cost of service report filed in this case on
16	September 8, 2017, relating to the areas of plant in service ("plant"), accumulated depreciation
17	reserve ("reserve") and depreciation expense. These cost components were used to develop
18	Staff's revenue requirement for Laclede Gas Company's ("LAC") and Missouri Gas Energy
19	("MGE") (collectively, "Company") rate cases filed by the Company on April 11, 2017.
20	Q. What is the purpose of your surrebuttal testimony?
21	A. I address the rebuttal testimony of the The Office of the Public Counsel's
22	("Public Counsel" or "OPC") witness John A. Robinett pages 3 to 4 relating to the area of
23	retirement work in progress ("RWIP").

1	Specifically, in his rebuttal testimony, Mr. Robinett identifies Public Counsel's position
2	regarding RWIP:
3 4 5 6 7 8 9 10 11	My concern is that if a retired plant asset is in an account with zero percent (0%) net salvage, there is no need to remove cost of removal or gross salvage from FERC account 108, Accumulated provision for depreciation. For accounts with zero percent (0%) net salvage, the cost of removal and the gross salvage value of retired plant have historically net out to zero. To state it another way, depreciation reserves are not overstated unless an account has experienced cost of removal in excess of gross salvage. (Robinett rebuttal, Page 3)
12	Q. Please summarize the differences between Public Counsel's position regarding
13	RWIP and Staff's position.
14	A. Staff made an adjustment to eliminate an overstatement to the depreciation
15	reserve at the end of the update period in this case June 30, 2017. This reserve overstatement
16	occurs when plant is retired at the end of the asset's useful life but has not yet been physically
17	removed, or disassembled. While both plant and reserve accounts have been adjusted to
18	remove the dollars associated with the retired asset, there are remaining dollars left in the
19	reserve for cost of removal and salvage. RWIP and the need for this adjustment are discussed
20	at page 47 of Staff's Cost of Service Report and identified in Staff's Accounting Schedule 6
21	Accumulated Depreciation Reserve and Accounting Schedule 7 Adjustments to Accumulated
22	Depreciation Reserve.
23	Public Counsel's position respecting RWIP balances appears to want to ignore the
24	reality that the accumulated depreciation in the form of cost of removal and salvage remain in
25	the reserve account at the end of either the update or true up period for plant that has been
26	retired and removed from service-the plant and its related reserve have been adjusted to
27	eliminate the dollar values of plant on rate base. Public Counsel's position respecting the

1 RWIP adjustments is that depreciation reserve balances for MGE are not overstated. Thus, Public Counsel is opposed to the RWIP adjustments for MGE.¹ 2

3 Public Counsel states, however, it does not take issue with the LAC's RWIP 4 adjustments, apparently agreeing that the retired plant at LAC leaves amounts in the reserve that otherwise needs to be removed.² 5

6

Q. Has LAC or MGE provided any testimony on this topic?

7 A. I was unable to find any direct or rebuttal testimony in either LAC or MGE's filings on the subject of RWIP. 8

9

O. What is **RWIP**?

10 A. RWIP stands for retirement work in progress. As discussed under section VIII. 11 Rate Base, A. Plant in Service and Depreciation Reserve at page 47 of the Cost of Service 12 Report, RWIP is the amount of depreciation associated with a plant asset still remaining in 13 depreciation reserve - Account 108, Accumulated Provision for Depreciation of Gas Utility 14 Plant - after the plant asset is retired. The amount left in the reserve subsequent to plant being 15 taken out of service relates to cost of removal and salvage. The plant and reserve balances 16 associated with retired plant have been removed from rate base through adjusting entries to the 17 individual account plant records at the time of the retirement. However, accumulated 18 depreciation in the form of cost of removal and salvage remain in the reserve account at the end 19 of either the update or true up period for plant that has previously been retired and removed 20 from service- the plant and its related reserve have been adjusted to eliminate the dollar 21 values of plant on rate base, but since the plant has not been physically removed, 22 the accounting entries have not yet been made to reduce amounts previously booked to account

for cost of removal and salvage. Since the actual removal of property and equipment has not
 occurred, and the corresponding cost of removal has not taken place, the accumulated reserve
 is overstated.

4 Q. Based on this explanation, what identifies the amounts currently in reserve and
5 how should those amounts be adjusted?

A. What is in reserve needing the adjustment is retired plant yet to be disassembled
(at this point an overstatement of the reserve) and when retired plant is finally dissembled, this
retired plant's cost of removal and any related salvage is also finally taken out of the reserve.

9 When the retired plant is actually disassembled, accounting entries are made to further
10 remove remaining portion of depreciation relating to cost of removal and salvage. These
11 accounting entries for the retired plant that is now physically removed from the utility's service
12 system eliminate the need for that particular amount of RWIP.

13 If there were no further retired plant, all things considered equally, there would be no
14 overstatement for the retired plant and no further need for the RWIP adjustments. Retired plant
15 and reserve would end the process for RWIP.

16

Q. What is the accumulated depreciation reserve?

A. The reserve is the tabulation, or the tracking of all depreciation of plant assets
charged to expense over the useful lives of the depreciable assets. In the accounting sense,
depreciation is the systematic allocation of plant asset costs over the useful service life of the
individual assets. In the ratemaking sense, depreciation represents the capital recovery of
assets deployed for public service by the utility through rates collected from customers.

22 The Accumulated Provision for Depreciation of Gas Utility Plant- Account 108 of the23 USOA states:

1 2 3 4 5 6	B. At the time of retirement of depreciable gas utility plant, this account shall be charged with the book cost of the property retired and the cost of removal and shall be credited with the salvage value and any other amounts recovered, such as insurance. ³ [Emphasis added]									
7	Q. What is the purpose of depreciation?									
8	A. For ratemaking purposes, depreciation is the systematic recovery from utility									
9	customers, of the capital investment used in the provision of utility service, in this case the									
10	provision of natural gas. Depreciation expense is charged against the recognition of revenues									
11	like other costs in determining the income from utility operations. Depreciation expense is									
12	credited monthly to the Reserve account (Account 108) which "accumulates" all current and									
13	prior depreciation. The total accumulated depreciation is a contra account to plant in service									
14	(Account 101), or a credit balance. The reserve amount is an offset to plant, as this represents									
15	prior recovery of the capital plant investment. Thus, the amounts of plant investment recovered									
16	from utility rates are accumulated in depreciation reserve. These already recovered asset costs									
17	are treated in the ratemaking process as a reduction to rate base. Once a utility recovers an									
18	asset in rates, customers are no longer required to provide a return to utility owners.									
19	Q. What is depreciation expense?									
20	A. Depreciation expense is the identification of amounts charged (debited) monthly									
21	to Account 403- Depreciation Expense for recovery of the individual assets classified and									

accounted for in various plant sub accounts of Account 101- Gas Plant in Service.
Account 403 captures the costs of the plant charged to the income statement on an annual basis
in the determination of utility income.

The USOA defines depreciation as:
B. Depreciation, as applied to depreciable gas plant, means the loss in service value not restored by current maintenance, incurred in connection with the consumption or prospective retirement of gas plant in the course of service from causes which are known to be in current operation and against which the utility is not protected by insurance. Among the causes to be given consideration are wear and tear, decay, action of the elements, inadequacy, obsolescence, changes in the art, changes in demand and requirements of public authorities, and, in the case of natural gas companies of exhaustion of natural resources.⁴
Q. How does depreciation work?

A. When the utility makes capital investments to plant, property, and equipment, upon completion of construction, the assets are accounted for in various plant property records. Most Missouri utilities use a property accounting system called Power Plant. Spire uses this record keeping system for all of its various utility properties including LAC and MGE. When plant assets are placed in service, the assets are "moved" in the accounting sense, to Account 101- Plant in Service, from Account 107- Construction Work in Progress-Gas. Once transferred to plant, depreciation starts immediately on the utility's records.

19 Plant investments are considered assets and are shown on the property records as debit 20 entries in the various plant accounts. Service lives for each category of assets are determined in 21 the context of a rate case to develop depreciation rates for each account. Those depreciation 22 rates are estimates of how long assets are expected to provide useful and necessary public 23 service. The individual depreciation rates are applied to the individual plant account balances 24 on a monthly basis to identify the amounts charged depreciation expense. The monthly 25 depreciation expense is "accumulated" in the depreciation reserve account. This process is 26 repeated throughout the useful life of the assets.

What are the accounting entries for depreciation?

A. Each month, an entry is made for depreciation to Account 403- Depreciation Expense as a debit with a corresponding entry to the reserve as a credit. As the utility "uses" the assets in the provision of utility service, it will depreciate those assets making this same accounting entry throughout the time the asset is in service. And each month the depreciation will increase the reserve. This accumulated reserve will continue to grow over time and is an offset (reduction) to plant, reducing the rate base as the accumulation takes place.

Simple entries to illustrate the accounting of depreciation and reserve can be made.

9 Assume plant investment of \$10,000 with a service life of ten years. Assuming no cost of
10 removal or salvage impacts, the yearly depreciation expense would be \$1,000. The table shows
11 the accumulation of the reserve as:

1 The total investment of \$10,000 is fully recovered at the end of the 10-year life of the plant 2 asset. The utility charged to depreciation expense (Account 403) the full \$10,000 asset value 3 over the 10-year asset life.

4

Q. What happens when the plant asset reaches the end of its life?

5 A. The utility retires the asset. For record keeping purposes, accounting entries are 6 made to each individual plant and reserve account to "remove" the now-retired asset from the 7 books and records of the utility-in this case LAC and MGE. For the example above, the 8 \$10,000 asset that is now retired, which will result in accounting entries needing to be made to 9 "retire" from service by crediting the various plant accounts for \$10,000 and debiting 10 accumulated reserve for \$10,000. The results of these entries will be to remove all impacts to 11 rate base and the plant accounting system for the now retired plant.

12 Q. Are there other aspects to depreciation besides the accounting and recovery of 13 plant assets?

14 A. Yes. While the purpose of depreciation is to identify and recover the costs of 15 an asset over its useful life, proper accounting and cost recovery of the investment also 16 considers the cost to physically remove assets- the cost of removal-- and any potential 17 residual value-- salvage. Both cost of removal and salvage are considered in the determination 18 of depreciation rates and are included in the calculations made on a monthly basis to determine 19 depreciation expense.

20

Q. What happens to the retirement of the plant asset when cost of removal and 21 salvage are considered?

22 A. Considering the same assumptions used in the above example, and adding in the 23 cost of removal and salvage components to depreciation, I can now illustrate what happens

with the accounting of depreciation and reserve when a retirement occurs similar to the
 retirements recently made by LAC and MGE.

Assume again the plant investment is \$10,000 with a service life of ten years. Assuming now cost of removal and salvage impacts of \$100 yearly in addition to the \$1,000 depreciation expense would total \$1,100 per year instead of the earlier example of \$1,000 per year. The table, reflecting cost removal and salvage now shows the accumulation of the reserve as:

At the time of retirement of the plant asset, the same accounting adjustments are necessary to take the retired plant off the books. However, since the disassembly of plant has

3

Q. Why is it necessary to make the RWIP adjustments for both LAC and MGE?

4 A. At the end of the asset's life, when all its costs are removed from plant and 5 reserve accounts, the cost of removal and salvage components of depreciation expense remain. 6 The RWIP adjustments made to the reserve of both LAC and MGE are necessary to prevent a 7 mismatch of rate base for the overstatement of reserve as result of the retirements. The effect 8 on plant and reserve is solved by making the necessary accounting entries-- so rate base is fixed 9 in that sense for the now retired assets-- but the cost of removal and salvage remain in the 10 reserve. There is no longer a plant investment, so retired plant-related reserve is removed, and 11 depreciation expense stops being charged and accumulating. But cost of removal and salvage 12 have not yet been addressed. In effect, this is a temporary timing issue.

13

Q. Why is this a temporary timing matter?

14 A. In every rate case, a cutoff is established to determine the cost of service levels 15 to set rates. In both the LAC and MGE rate cases, September 30, 2017, is the procedural date 16 that the Commission authorized as the point in time to identify the rate base components with 17 revenues and expenses. Plant, reserve, and depreciation expense all are being set using 18 September 30, 2017, as the cutoff. Any retirements that occurred as of September 30, 2017, 19 will not be included in the plant and reserve accounts. But typically small dollar amounts of 20 depreciation will remain in the reserve for a temporary period of time. Both cost of removal 21 and salvage will be eventually addressed as well when the retired plant is physically removed, 22 deconstructed, and disassembled. At this time the exact date for this is unknown.

Q. How does the overstatement of reserve impact the cost of service in these
 rate cases?

A. Normally the RWIP amounts that remain in the reserve temporarily do not have a financial impact on LAC and MGE. But in the context of a rate case, the overstatement of reserve has an adverse impact on the rate base. The overstated reserve causes an understatement of rate base. This results in a lesser revenue requirement.

How were the RWIP adjustments determined?

8 A. The plant accounting record system of LAC identifies the amounts at the point 9 in time for the cutoff. LAC has set a sub account of the reserve (Account 108) called 10 Account 108.100 to capture the retired plant-related cost of removal and salvage. For the 11 update period of June 30, 2017, that is the ending point for Staff's case filed in direct 12 testimony, the Company supplied detailed work papers showing the amounts of RWIP. 13 That detail was the basis of adjustments made in the LAC and MGE filings. The same work 14 papers for both companies were updated for the September 30, 2017 true-up. Surrebuttal 15 Schedule CGF-s1, is a copy of the true-up work papers supplied by LAC relating to the 16 September 30, 2017, true-up RWIP. This schedule shows the detailed RWIP amounts that need 17 to be removed for retire plant to avoid the overstatement of the LAC and MGE reserves.

18

Q. Will it be necessary to make the RWIP adjustments for the true-up?

A. Yes. Staff is currently working on the September 30, 2017, true-up. I have the
adjustments necessary to include in the true-up revenue requirement calculations. The table
below identifies the true-up RWIP adjustments compared to those made in the direct filing at
the June 30, 2017 update:

Q. Has Staff made RWIP adjustments in other rate cases?

A. Yes. RWIP adjustments are made in the same manner as what has been done
with LAC and MGE in the Kansas City Power & Light Company ("KCPL") and KCP&L
Greater Missouri Operations Company ("GMO") rate cases. I have worked on numerous
KCPL and GMO rate cases, as well as GMO's predecessor company called Aquila, Inc., and
prior to that UtiliCorp United Inc., and those companies all had the need for RWIP adjustments
that had to be considered in past rate cases.

Q. Did Public Counsel recognize the need to make the RWIP adjustment in theseprior cases?

A. Yes. Additionally, Public Counsel witness Robinett indicated at page 4 of
his rebuttal testimony that Public Counsel has no issue with the RWIP adjustments for LAC.
The sole issue Public Counsel is taking is with the RWIP amounts for MGE.

Q. Public Counsel witness Robinett indicates it is not necessary to consider RWIP adjustments if "accounts with zero percent (0%) net salvage, the cost of removal and the gross

1 salvage value of retired plant have historically net out to zero."⁹ Do you agree with
2 Mr Robinett on this point?

A. Yes. To the extent a particular account has a zero cost of removal and salvage amount, there should be no RWIP to consider. As discussed above, LAC and MGE specifically identify, at the end of each month, amounts for RWIP. Both entities have identified in these cases the update and true-up amounts in RWIP (Account 108.100). The RWIP amounts are able to be identified because LAC and MGE maintain detailed accounting for the retired assets and related RWIP. It is this detailed accounting that formed the basis for the adjustments made in the LAC and MGE rate cases.


