**ORDER SUSPENDING REQUIREMENT TO FILE SURREBUTTAL  
TESTIMONY ON REVENUE REQUIREMENT AND RATE DESIGN  
ISSUES**

The procedural schedule established for this case requires the parties to file surrebuttal testimony on all issues no later than April 11, 2022. On April 8, 2022, The Empire District Gas Company d/b/a Liberty or Liberty Utilities, on behalf of itself, Commission Staff, Office of the Public Counsel, Midwest Energy Consumers Group and the Missouri School Boards Association (MSBA), filed a motion indicating that the parties have reached an agreement in principle that would settle all revenue requirement and rate design issues, except those issues raised by the MSBA. The motion asks the Commission to suspend the requirement to file surrebuttal testimony on revenue requirement and rate design issues. Surrebuttal testimony regarding the MSBA issues will still be filed no later than April 11, 2022 as scheduled. The remainder of the procedural schedule will remain in place to resolve the MSBA issues.

The Commission will grant that motion.

**THE COMMISSION ORDERS THAT:**

1. The Motion to Suspend the Filing of Surrebuttal Testimony on Revenue Requirement and Rate Design Issues is granted.
2. This order shall be effective when issued.
