**ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND
ESTABLISHING TIME FOR RESPONSE**

On November 4, 2021, Summit Natural Gas of Missouri, Inc. (Summit) filed tariff sheets that would make an adjustment to the winter Purchased Gas Adjustment (PGA) rate for three of its service areas. Summit is proposing to adjust the current cost of gas factor. The tariff sheets have a proposed effective date of November 15, 2021. The Commission will direct the Staff of the Commission to file a recommendation on Summit's tariff sheets on an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Summit's tariff sheets no later than November 9, 2021.
2. Any other entity wishing to comment on the tariff sheets or Staff's recommendation shall do so no later than November 9, 2021.
3. This order shall be effective when issued.
