The Commission’s Staff (Staff) submitted its recommendation concerning Spire West’s Actual Cost Adjustment filing on December 15, 2022. Staff’s recommendation proposed several cost disallowances. Staff and Spire West continue to discuss settling those disallowances. Staff’s March 17, 2023 status report suggested the Commission order the parties to submit a proposed procedural schedule or another status report by May 22, 2023. The Commission agrees with Staff’s suggestion and will direct the parties to submit a proposed procedural schedule or another status report.

THE COMMISSION ORDERS THAT:

1. The parties shall file a joint proposed procedural schedule or a status report no later than May 22, 2023.

2. This order shall be effective when issued.
