ORDER GRANTING APPLICATIONS TO INTERVENE

On April 1, 2022, Spire Missouri Inc. d/b/a Spire submitted tariff sheets to initiate a general rate case. The Commission issued an order directing notice, and setting a deadline of April 25, 2022, for requests to intervene. The City of Kansas City, Clearwater Enterprises LLC, and the Missouri School Boards' Association all filed timely applications to intervene. Ten days have elapsed, and no party has objected to the applications to intervene.¹

Commission Rule 20 CSR 4240 2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The applications satisfy the requirements of Commission Rule 20 CSR 4240-2.075 and serve the public interest. The Commission will grant intervention.

THE COMMISSION ORDERS THAT:

1. The applications to intervene filed by The City of Kansas City, Clearwater Enterprises LLC, and the Missouri School Boards' Association are granted.

¹ Commission rule 20 CSR 4240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission.
