## ORDER DIRECTING RESPONSE

On November 3, 2022,<sup>1</sup> Summit Natural Gas of Missouri, Inc. (SNGMO) filed tariff sheets to reflect changes in the company's Regular Purchased Gas Adjustment clause. The tariff sheets were assigned Tracking No. JG-2023-0087. The tariff sheets that were filed on November 3 have an effective date of November 21.

On November 4, SNGMO filed substitute tariff sheets under Tracking No. JG-2023-0087. The tariff sheets filed on November 4 have an effective date of November 17. There was no request or statement from SNGMO explaining the changed effective date.

The Commission will direct SNGMO to file a response which requests and explains the change of effective dates. The Commission will also establish a deadline for any other entity to file a response to the change in effective dates.

### THE COMMISSION ORDERS THAT:

1. No later than November 9, 2022, SNGMO shall file a response requesting and explaining the change of effective dates.
2. Any other entity wanting to comment on the change of effective dates shall do so no later than November 10, 2022.
