On March 4, 2022, Spire Missouri Inc. d/b/a Spire Missouri East and Spire Missouri West (Spire) filed tariff sheets to reflect changes in accordance with its Weather Normalization Adjustment Rider for its eastern and western Missouri operating divisions. The tariff sheets bear an effective date of April 1, 2022.

The Commission will direct the Staff of the Commission to file a recommendation and will establish a deadline for any other entity to file a response to the tariff sheets.

THE COMMISSION ORDERS THAT:

1. No later than March 11, 2022, the Staff of the Commission shall file a recommendation with regard to the above referenced tariff sheets.
2. Any other entity wishing to comment on the tariff sheets shall do so no later than March 11, 2022.
3. This order shall be effective when issued.
